



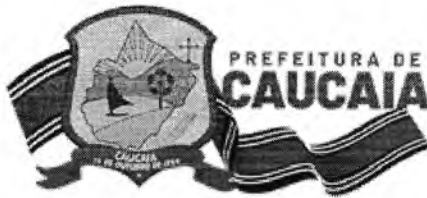
**ATA DE ANÁLISE E JULGAMENTO DOS DOCUMENTOS DE HABILITAÇÃO DA CONCORRÊNCIA PÚBLICA Nº 2022.07.27.01-SPT**

Aos 27 (vinte e sete) dias do mês de janeiro de 2023, às 15h23min, a Comissão Permanente de Licitações composta por Wagner Vieira Vidal - Presidente, Maria Silviane Gois da Silva – Membro, e Alden Christian Pinheiro de Barros – Suplente, nomeados por meio da Portaria nº 105, de 19 de agosto de 2022, reunidos na sala de sessões localizada no Departamento de Gestão de Licitações, sito a Rua Coronel Correia, nº 1073 – Parque Soledade – Caucaia/CE, concluíram a análise interna dos documentos de habilitação dos 189 (cento e oitenta e nove) licitantes classificados na fase de propostas técnicas e 27 (vinte e sete) licitantes do cadastro reserva, tudo conforme o instrumento convocatório da **CONCORRÊNCIA PÚBLICA Nº 2022.07.27.01-SPT**, que tem como objeto a **DELEGAÇÃO DE PERMISSÃO DE USO PARA OPERACIONALIZAÇÃO DO SERVIÇO DE TRANSPORTE ESPECIAL DENOMINADO BUGGY-TURISMO DO MUNICÍPIO DE CAUCAIA/CE** e preceitos da Lei nº 8.666/93 e suas alterações posteriores. A Comissão frisou que os envelopes nº 1 com os documentos de habilitação dos licitantes, foram abertos em sessão pública realizada no dia 05 de janeiro de 2023 e que desde esta data, a comissão estava, se dividindo entre seus afazeres e trabalhos diários, para realizar a análise interna dos documentos, conforme exigências e condições previstas no item 6 do edital e sempre adotando como data-base o dia 17 de outubro de 2022, data limite do certame para a entrega dos envelopes com documentos de habilitação e propostas técnicas. Sabendo disto, a Comissão enfatizou que todas as certidões apresentadas pelos licitantes, deveriam estar válidas na data supracitada para fins de habilitação. Contudo, a Comissão chegou ao julgamento contido no quadro detalhado anexo a presente ata.

A Comissão ressaltou que, mantendo o mesmo entendimento consolidado na CONCORRÊNCIA Nº 2022.02.22.01-SPT, a análise e julgamento levou em consideração os seguintes pontos:

1. Após a análise de todos os documentos de habilitação, esta Comissão se ateve em consultar os documentos das propostas técnicas dos licitantes que haviam deixado de apresentar algum documento exigido no item 6 do edital para fins de habilitação, para verificar se estes haviam se confundido no momento da confecção/montagem dos envelopes e apresentaram, no conteúdo do invólucro nº 2 (propostas técnicas), documentos exigidos para fins de habilitação. Contudo, constatou-se que: a) o Sr. JOSE ROBERTO DE LIMA ARAUJO que havia deixado de apresentar a CNH nos documentos de habilitação, apresentou-a na documentação de proposta técnica (fl. 1100 dos autos); b) o Sr. MARCELO DOS SANTOS SOUSA FILHO que havia deixado de apresentar as certidões negativas de débitos nos documentos de habilitação, apresentou-as na documentação de proposta técnica (fls. 834 a 841 dos autos); e c) o Sr. FRANCISCO GABRIEL DA SILVA DOS SANTOS que havia deixado de apresentar as certidões negativas de débitos nos documentos de habilitação, apresentou-as na documentação de proposta técnica (fls. 1612 a 1624 dos autos). Logo, considerando que: 1 – o item 8 do edital prevê que o presente certame tem as fases invertidas, ou seja, que os envelopes com propostas técnicas seriam abertos antes dos envelopes com documentos de habilitação; 2 – que tanto os envelopes com documentos de habilitação quanto os envelopes com propostas técnicas foram apresentados no mesmo momento (em 17 de outubro de 2022); 3 – que o Acórdão 1211/2021-TCU-Plenário prevê que: **“Admitir a juntada de documentos que apenas venham a atestar condição pré-existente à abertura da sessão pública do certame não fere os princípios da isonomia e igualdade entre as licitantes e o oposto, ou seja, a desclassificação do licitante, sem que lhe seja conferida oportunidade para sanear os seus documentos de habilitação e/ou proposta, resulta em objetivo dissociado do interesse público, com a prevalência do processo (meio) sobre o resultado almejado (fim) . O pregoeiro, durante as fases de julgamento das propostas e/ou habilitação, deve sanear eventuais erros ou falhas que não alterem a substância das propostas, dos documentos e sua validade jurídica, mediante decisão fundamentada,**

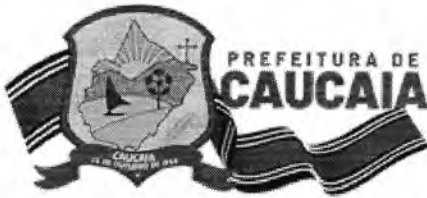

registrada em ata e acessível aos licitantes, nos termos dos arts. 8º, inciso XII, alínea "h"; 17, inciso VI; e 47 do Decreto 10.024/2019; sendo que a vedação à inclusão de novo documento, prevista no art. 43, §3º, da Lei 8.666/1993 e no art. 64 da Nova Lei de Licitações (Lei 14.133/2021), não alcança documento ausente, comprobatório de condição atendida pelo licitante quando apresentou sua proposta, que não foi juntado com os demais comprovantes de habilitação e/ou da proposta, por equívoco ou falha, o qual deverá ser solicitado e avaliado pelo pregoeiro."; 4 – que esta Comissão verificou os autos do presente certame e constatou que os documentos contidos nos envelopes com propostas técnicas dos licitantes supracitados estavam em condição pré-existente à abertura da sessão pública do certame, ou seja, atestando que até a data de recebimento dos envelopes (17/10/2022), não constavam crimes eleitorais, civis, criminais ou patrimoniais contra os licitantes e/ou que estes estavam com as Carteiras Nacionais de Habilitação válidas. Destarte, ficou evidente que trata-se de erro ou falha cometida pelos licitantes no momento de preparação dos envelopes, e que por não alterar a substância das propostas, nem tampouco dos documentos e da sua validade jurídica, esta Comissão decide, em cumprimento ao Acórdão nº 1211/2021-TCU-Plenário, sanar os equívocos cometidos pelos licitantes, uma vez que estampou-se que não se trata de inclusão de documento novo, mas tão somente a reprodução/cópia de documentos já apresentados em momento anterior ao da presente sessão. Contudo, será anexo à presente ata as cópias promovidas pela Comissão da referida documentação.

2. Foram encontradas, no conteúdo dos documentos de habilitação apresentados, Carteiras Nacionais de Habilitação – CNH's vencidas na data-base de julgamento dos documentos (17/10/2022). Entretanto, verificou-se o Art. 162, inciso V do Código de Trânsito Brasileiro (LEI nº 9.503, de 23 de setembro de 1997) permite o uso e considera como válidas as CNH's até 30 (trinta) dias após o prazo de validade do documento. Contudo, a Comissão atentou que todas as CNH's apresentadas e que estavam vencidas no dia 17/10/2022, também estavam dentro dos 30 (trinta) dias permitidos pelo CTB. Logo, para fins de lei, os documentos estão válidos e a exigência do subitem 6.4.2 do edital restou atendida.
3. Com base na permissão concedida no item 20.2 do edital, esta Comissão entende que a declaração tratada no item 6.6.9 e Anexo XI do Edital visa apenas comprovar que os participantes deste certame residem no Município de Caucaia/CE no presente ano. Considerando também que a Lei Federal nº 8.987 de 13/02/95 e suas alterações, e a Lei Municipal nº 3.487 de 22 de julho de 2022, ou qualquer outra legislação aplicável e vigente não preveem tempo mínimo de residência dos permissionários. Considerando ainda que o art. 1º da Lei nº 7.115, de 29 de agosto de 1983 versa que: **"A declaração destinada a fazer prova de vida, residência, pobreza, dependência econômica, homonímia ou bons antecedentes, quando firmada pelo próprio interessado ou por procurador bastante, e sob as penas da Lei, presume-se verdadeira."** Logo, visando ampliar a competitividade e atender aos princípios da legalidade, do julgamento objetivo e formalismo moderado, esta Comissão optou por desconsiderar o tempo mínimo de residência previsto no instrumento convocatório e aceitar como prova de residência, toda declaração apresentada assinada pelos licitantes, onde os mesmos atestam que residem no Município de Caucaia/CE.
4. Os licitantes que apresentaram certidões de antecedentes criminais onde constava algum processo civil ou criminal, tiveram os processos consultados por esta Comissão, junto aos sítios eletrônicos dos órgãos emissores das certidões, para fins de verificar o cumprimento do subitem 6.4.1 do edital e validar a informação que não se tratavam de crimes de homicídio, roubo, estupro, tráfico de drogas e corrupção de menores.
5. As certidões que não detinham data de emissão no seu conteúdo, foram validadas por esta Comissão junto aos sítios eletrônicos dos órgãos emissores para fins de verificação da sua validade na data-base de julgamento dos documentos de habilitação.
